



# CIA Qualification Pathways – Simplified

## Pathway 1

Designed for students using an accredited degree and exclusively using the CIA's education and exams to achieve ACIA and FCIA designations.

## Pathway 2

Designed for candidates who want to hold another recognized Associate-level designation and become ACIAs and FCIAs through the CIA's education and exams and who do not plan to become Fellows of another actuarial organization.

Also for candidates seeking ACIA designation via mutual recognition agreements and the Affiliate route, e.g., ASA/FCIA, ACAS/FCIA, ASSA/FCIA, AIAA/FCIA, AIA/FCIA, etc.

## Pathway 3

Designed for candidates who want to hold another recognized Fellow-level designation and become FCIsAs via experience, fast-track or mutual recognition, e.g. FSA/FCIA, FCAS/FCIA, FASSA/FCIA, FIAA/FCIA, FIA/FCIA.
